

Conditions for the validity of Fire Safety Certificate

1. All the means of escape shall be kept free of all types of obstruction all the time.
2. All the fire safety arrangements provided there in shall be maintained in good working condition at all time.
3. Any loss of life or property due to non-functional fire safety measures shall be at the responsibility of the management.
4. The compliance with regards to electrical installation, structural stability, set back area, occupancy and any deviation in construction etc. shall be verified from authority concerned.
5. Basement shall be used as per NBC(BBL) 1983.
6. Any deviation w.r.t construction etc. shall be verified by the concerned building sanctioning authority.
7. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
8. The owner occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'F' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry.
9. Any flammable material for interior decoration shall strictly prohibited.
